Curriculum Code: 0162 (Effective Fall 2016 – Summer 2021)

Graduates of this degree are qualified to work as a paraprofessional in most areas of accounting, such as financial reporting, cost accounting, governmental accounting, tax preparation and auditing. Typically the paraprofessional works under the supervision of a professional accountant, but may be doing essentially the same types of work. Job titles include full-charge bookkeeper, tax preparer, and internal auditor, among others. **Not all courses in this program transfer to all colleges.** Students planning to transfer should see an academic advisor before enrolling in any course.
