## **Cocurricular discussion**

Review original inclusionary and exclusionary definitions from <u>the Cocurricular Assessment Plan handout</u> located on CASL SharePoint Site.

- After discussion determined to remove the bullet item "May or may not be led by LCC" from the Cocurricular Definitions and Inclusion Criteria section
- Is there some reason we wouldn't want to assess the type of learning that goes on with student government?
  - Does someone run it, is it a program that someone can facilitate assessment there?
  - While learning exists not sure how we would measure that.

- Important to remember that the fact something isn't included in cocurricular doesn't mean it doesn't have value or add to learning
  - It might be extracurricular as opposed to something that falls into a category that can be assessed the way cocurricular programs are being defined
  - Other areas can still be evaluated but through different channels than cocurricular assessment
- Another way to determine if something is cocurricular is if they have completed an intentional instructional design
- Do not like using the terms "exclusion" and "inclusion" for section headings in the guide.
  - Need to be revised
  - Could say something like, "Examples of cocurricular" in place of Inclusion List; and "Examples of extracurricular" in place of exclusion or undecided list.
  - CASL to update that terminology in the cocurricular handbook

# Create up-to-date list.

- Items on the included list all have a clear direct link that the activity can be tied back to student learning in specific classes
- All programs will be evaluated in some form, what we are trying to decide here is which ones will be assessed for learning and linked to one or more ELO
- HLC viewpoint is that if something is on the cocurricular list it needs to be assessed.
- After discussion the group is satisfied with the list as it stands

# CASL Website updates – Tim and Team

- Team met this week and seems to be going well.
- Goals: Using site to advance general education assessment at the college.
  - Practical for faculty
  - Located in a place faculty would naturally migrate
    - That is not the Senate Website
    - Currently thinking to create a LIB Guide
  - In short term have information that is generally educational on assessment for faculty but in longer term have specific to LCC itself
- Kara and Danielle met yesterday and came up with categories that could be tabs on the website.
  - o Phase One
    - Getting started with Assessment
    - Course Design Assessments
    - Using D2L for Assessment
    - Getting Help with Assessment
  - o Future items
    - Assessment Outside of D2L
    - Analyzing Assessment Data
    - Equitable Assessment
    - Academic Integrity/Cheating
  - Some items have existing information and some needs to be created will be asking CASL help to get content onto the website.

# <u>ChatGPT – standing discussion topic</u>

- Senate today passed resolution creating a workgroup to draw together various divisions, departments and programs, across LCC talking about AI and implications it may have for college.
  - That group needs volunteers
  - Would be good to have some CASL representation there

  - An AI resource directory

  - Group determined worth keeping, a place where people can bring up concerns and possibly receive updates from the LCC-wide AI workgroup
- Tim reminded folks they can always add agenda items for CASL discussion.

## Honors program discussion.

  - After today's discussion determined Tim will asked to be removed from the Oct 6<sup>th</sup> Senate agenda so that he can incorporate what is learned during the Oct 6<sup>th</sup> CASL discussion when speaking to Senate
- Dina Krois and Jessica Hester have been invited to the October 6, 2023 CASL meeting.
- English department discontinued ENGL 131 and 132 honors programs.
  - That now makes the ENGL program in line with others at LCC, having an Honor's option instead of dedicated courses
  - Does this mean we no longer need to bring the issue to Senate?
    - Did this move address the concerns of some CASL faculty?
    - Still question of recruitment from white colleges?
