"Rise" is an intransitive verb, such that the sun can rise or a person can rise in the morning...but of course that sort of by-itself-ism isn't what you intend here. Moreover, like I say, "in relationship to" I guess means sorta "because" here, but it doesn't seem strong enough, and most likely there's a tighter phrase anyway. <br> - Here is my guess on your intent for $\mathbf{1}$ ) and $\mathbf{2 )}$ : "The student's grade can be improved by [increased by/raised by (?)] successfully completing additional competencies in any category" (?). <br> - Oops, 'nother one, in last paragraph of "Notes": 3) "however" is not a coordinating conjunction, meaning it cannot connect sentences with only a comma like "and" or "but" can. If you want to keep the "however," just shift the comma before it to a semicolon.
